# Dear Minister,

On behalf of UKEVENTS, the collective voice of the UK's world leading Events Industry, I warmly congratulate you on your well-deserved appointment as Chancellor of the Duchy of Lancaster.

I'm sure you will recall my pleadings to you, whilst you were Secretary of State at DCMS, for greater recognition of the UK Events Industry and its role in, not only the recovery of Tourism, but in the wider economy.

More than ever, the UK Events Industry is now of critical importance in supporting the delivery of the government's growth agenda and providing a highly competitive and productive platform for UK businesses to do business. Business events held in the UK and abroad generate trade, exports, inward investment, regeneration, knowledge exchange and scientific and technological innovation, as well as providing a showcase for Britain on the global stage. This is the result of the UK having resilient, highly innovative, world-class conference, exhibition and trade fair sectors that are estimated to generate 165 billion of trade transactions annually from both UK and international businesses.

The Industry is grateful to you for ensuring that business events, accounting for half of all spend in the visitor economy, were fully included in the Tourism Recovery Plan. Spend is currently estimated to be worth around £50 billion. However the Industry is targeting to build back to pre-pandemic levels in excess of £70 billion within the next eighteen months. The Industry's Recovery Plan sets out new initiatives that will improve the already strong offer of the UK as a world destination of choice for meetings, conferences and exhibitions, so that it can retain its unrivalled position as the world's meeting place. Current initiatives include measures that will prioritise events in the Government's target economic and business sectors.

The Industry strongly believes there are significant untapped opportunities which would support the Government's objectives for the growth of the economy, if the Events sector was given a more strategic role in the delivering and implementing of government policies and

there was greater Ministerial advocacy and support for specific events together with greater alignment to priority economic sectors. This does require more collaboration of resource across Government Departments, as several, including your own Department, DCMS, BEIS, DIT and several others, together with agencies such as the Arts Council, UK Sport and VisitBritain are key stakeholders in this process too. A review of how resources across Government departments are utilised to optimise the value of events to the economy may well help the current process of securing further government efficiencies.

In your new role, with responsibility for oversight of Government policies and major events, I hope, you would agree to discuss further how the opportunities from business events can be even more greatly leveraged to support the Government's agenda and meet your Department's policy objectives.

In the meantime, as a Bushey Heath resident and one of your ardent constituents, I wish you every success in your new role.
